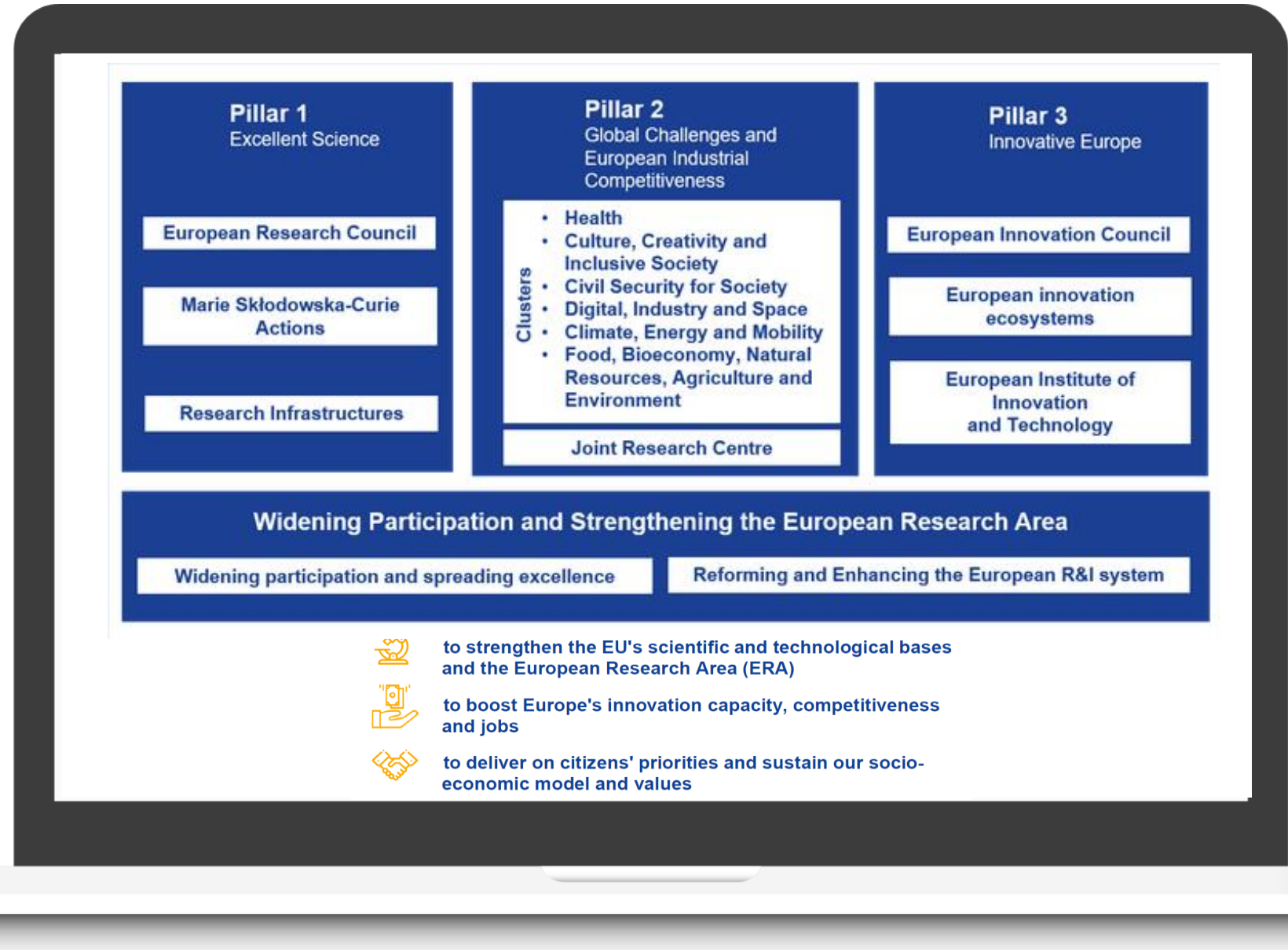

The 3 Pillars



Innovation Budget



INNOVATION & COMPETITIVENESS

- **1.6-fold** increase of the funding for research, innovation and digital to enable Europe to keep up with its global competitors.
- **€650 billion** of investments will be leveraged under the InvestEU Programme.
- **Horizon Europe:** largest envelope ever for research and innovation.
- **Cohesion policy:** thematic concentration requirements to dedicate funding to "a smarter Europe".
- **Digital Europe:** new dedicated programme to embrace digital transformation.

- HEU = € 100 billion
- Digital Europe = € 9 billion
- InvestEU = € 200 billion R&I
- SMEs = € 215 billion

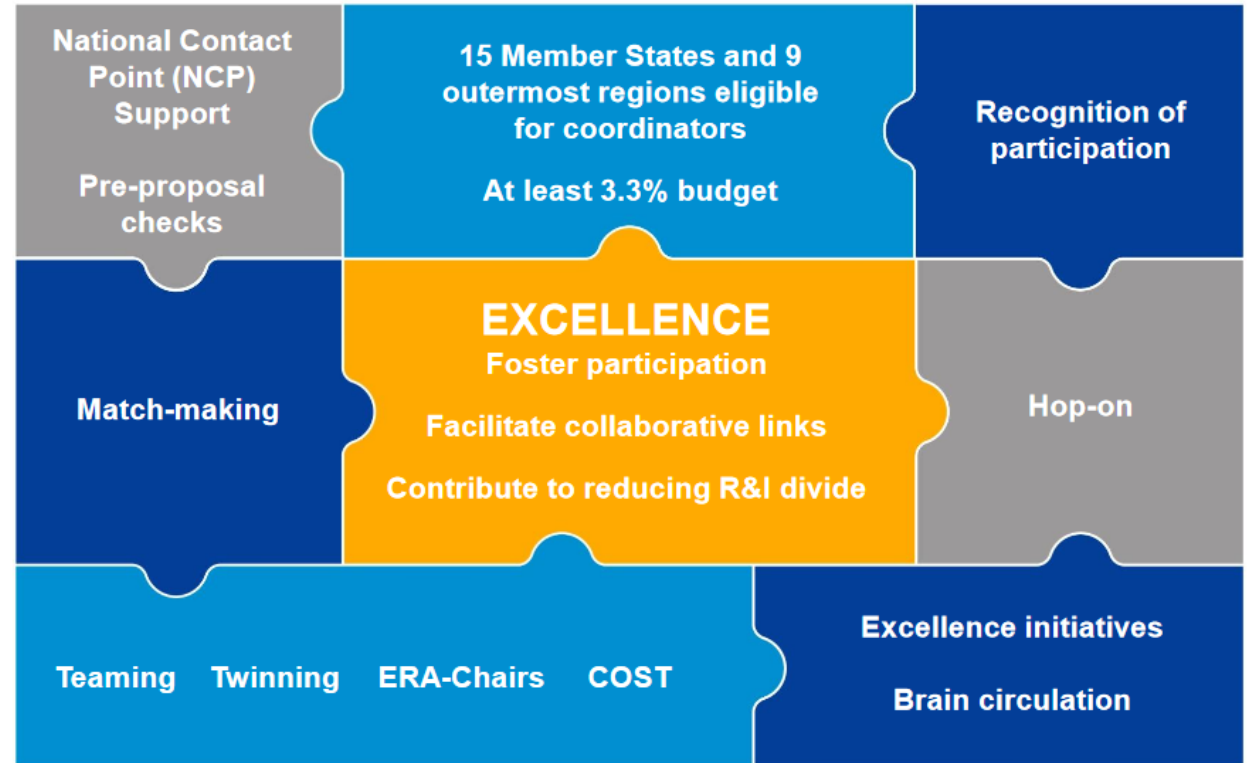

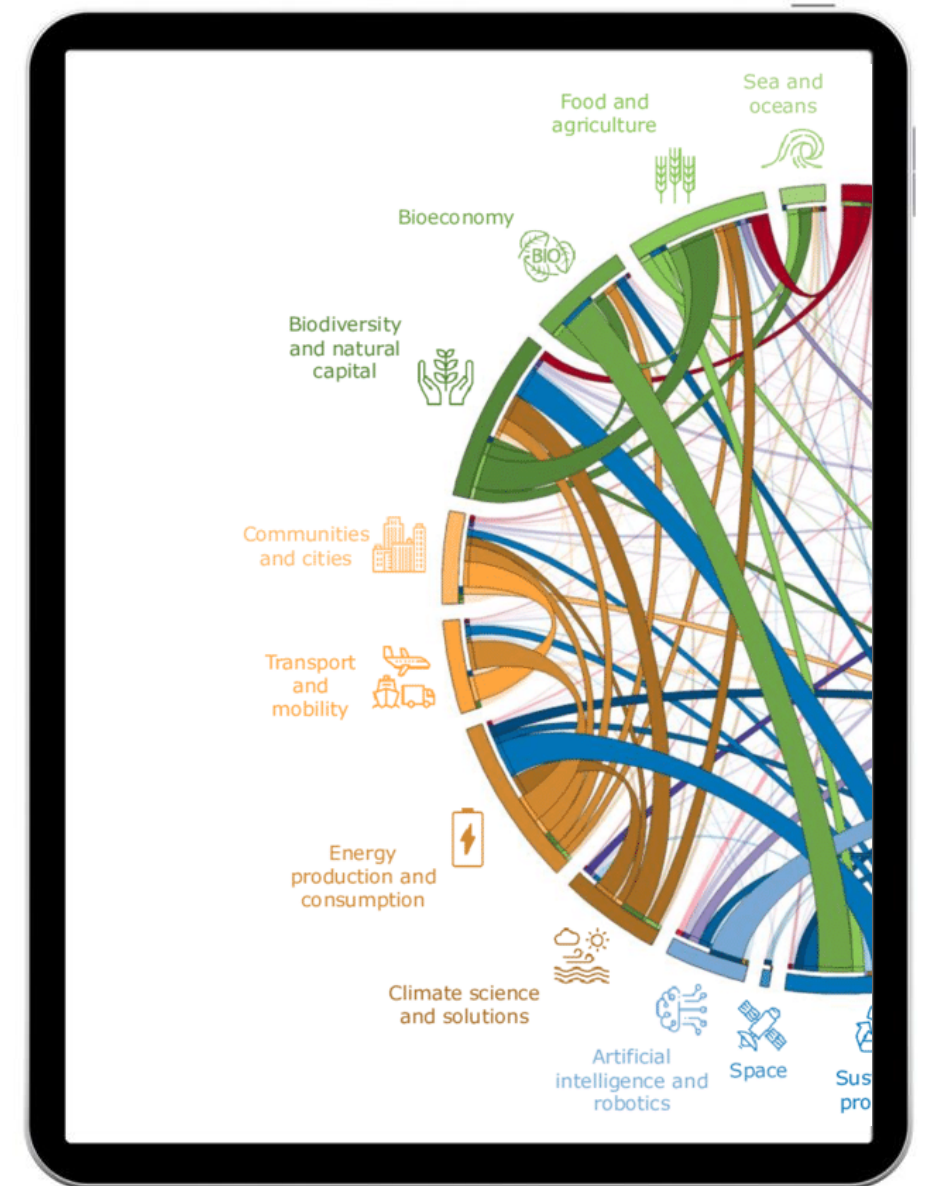

- Social sciences and humanities will be integrated across all clusters
- Research and Innovation is grouped into integrated clusters of activities
- No thematic set of clusters is intended for one set of actors from scientists to innovators, to businesses.

How to support them

What measures will be adopted to support the European Innovation Ecosystems?

- co-funding partnership initiatives (in particular with national innovation agencies)
- increased use of innovation procurement

What activities are foreseen?

- mentoring, coaching, technical assistance and other soft skills
- and services for innovative enterprises delivered close to innovators by networks (EEN, Startup Europe, etc) + INNOSUP actions

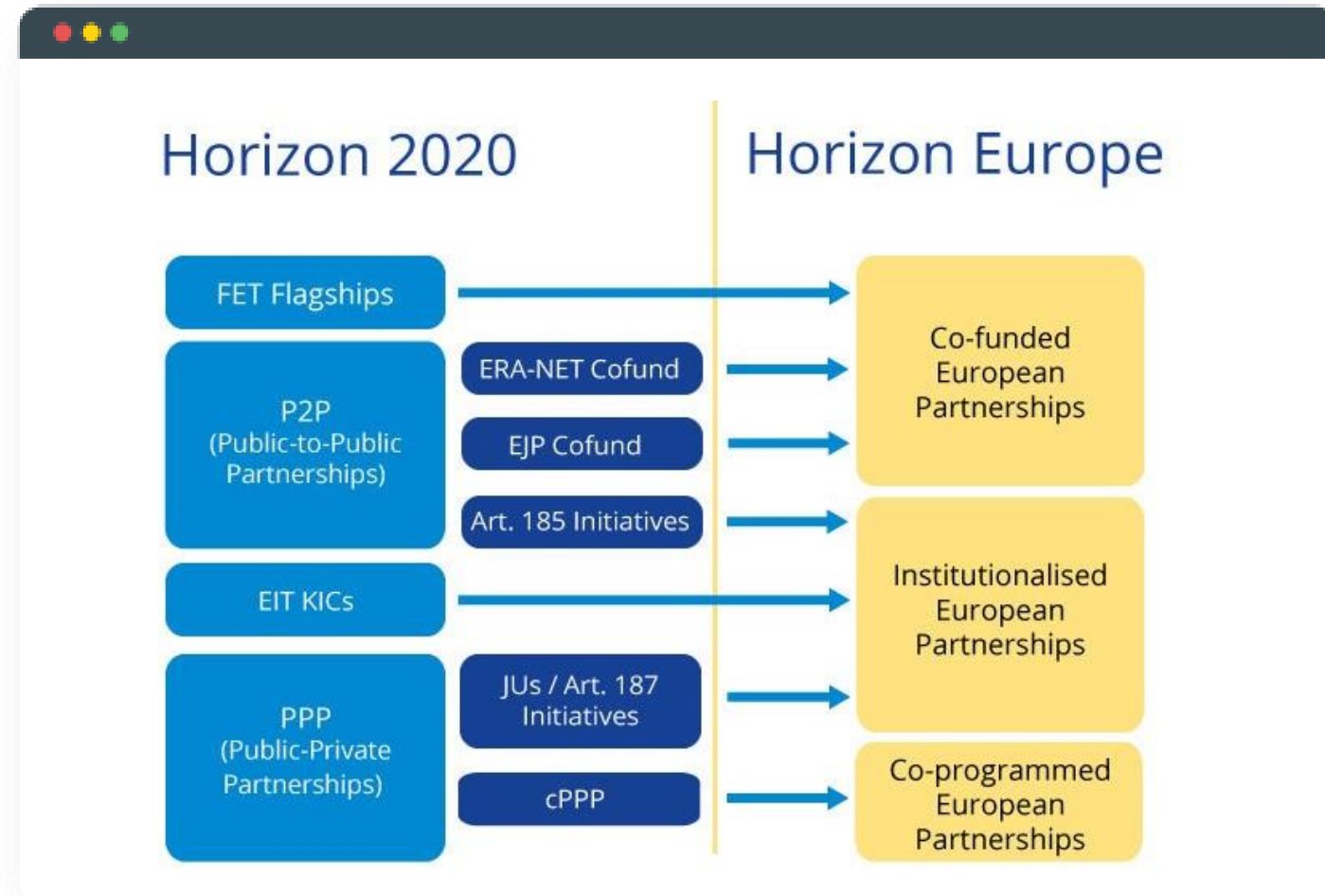


New approach to partnerships

& increased collaboration with other EU Programmes

For the first time, an **overall policy approach for all kinds of partnerships**, from ERA-NETs to JTI, FET Flagships and even the EIT/KICs has been developed and uniformly labelled **‘European Partnerships’**.

Proposal preparation

Planned changes:

- Emphasis shall be put on **non-prescriptive** calls for proposals, allowing for multiple ways to achieve the impact (Global Challenges and European Industrial Competitiveness' and the 'Innovative Europe' Pillars)
- More frequent use of **multiannual topics**, with a choice of submission deadlines spread over more than one year
- In some topics the applicants may be allowed to decide on the most appropriate **type of action** for achieving the targeted impact

Issues under discussion: **Deadline modes**



Submission and Evaluation

Planned changes:

- Approaches may vary from mission to mission
- Possible use of 'blind' evaluation in the first stage of two stage procedures
- Further simplifying two-stage
- Possible re-calibration of the scoring system to increase the range above threshold
- Simplification of the number of aspects to be considered
- Potential reduction to max. 50 pages of proposal.

Dissemination and Exploitation

Planned changes:

- **Continuous reporting** beyond the end of the project on D&E activities and **adapting the reporting templates**
- **Enhanced guidance and support to applicants** offered by the EC on dissemination and exploitation strategy.
- **Enhanced D&E support to projects based on the reported needs**

- Focus will be on **the timely knowledge diffusion towards the concerned stakeholders**



Dissemination and Exploitation

In the Grant Agreement - a new article

Cannot manage to exploit your results within the Grant Agreement period?

Use the online platform which was identified in the Grant Agreement to find interested parties who could exploit those results.

If justified on the basis of a request of the beneficiary, this obligation may be waived.

Personnel cost calculation (Part 1)

Eligible personnel costs are limited to salaries

In Horizon Europe you can:

- include net payments during parental leave, social security contributions, taxes and other costs linked to the remuneration, if they arise from national law or the employment contract (or equivalent appointing act).

How should it be calculated?

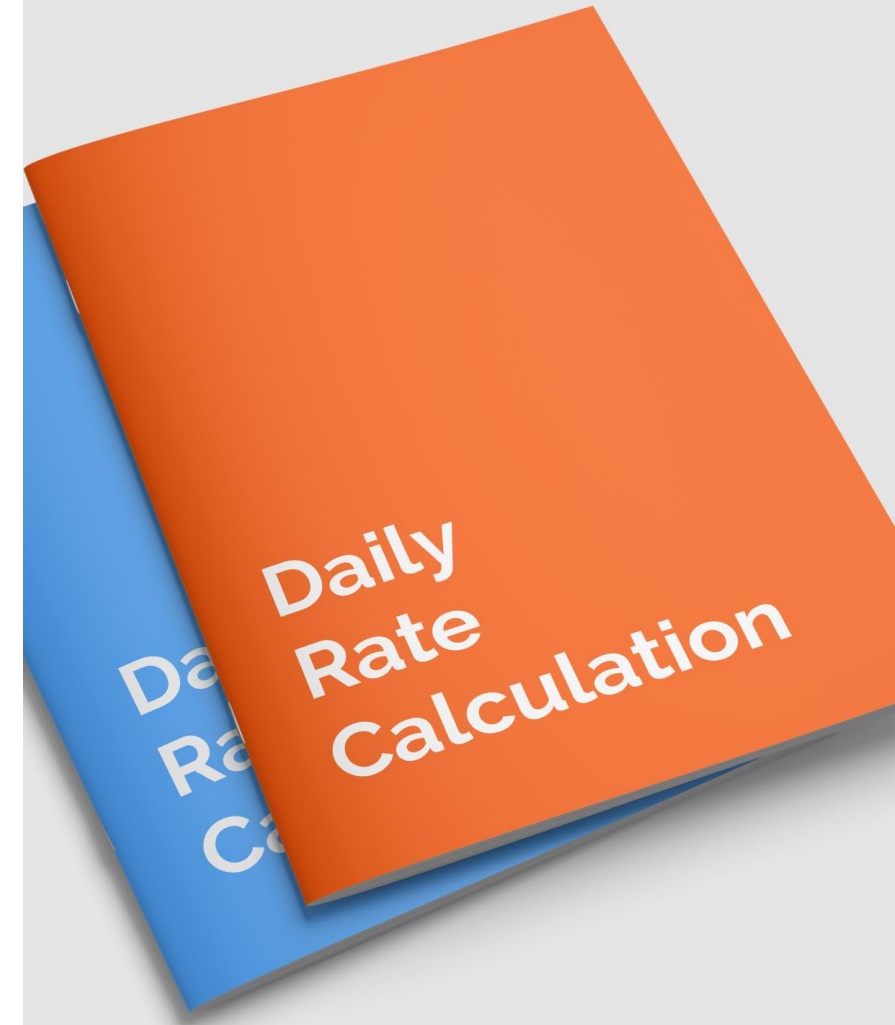
and be calculated as follows:

Daily rate



Days worked

{daily rate for the person multiplied by number of actual days worked on the action (rounded up or down to the nearest half-day)}

Personnel cost calculation (Part 2)

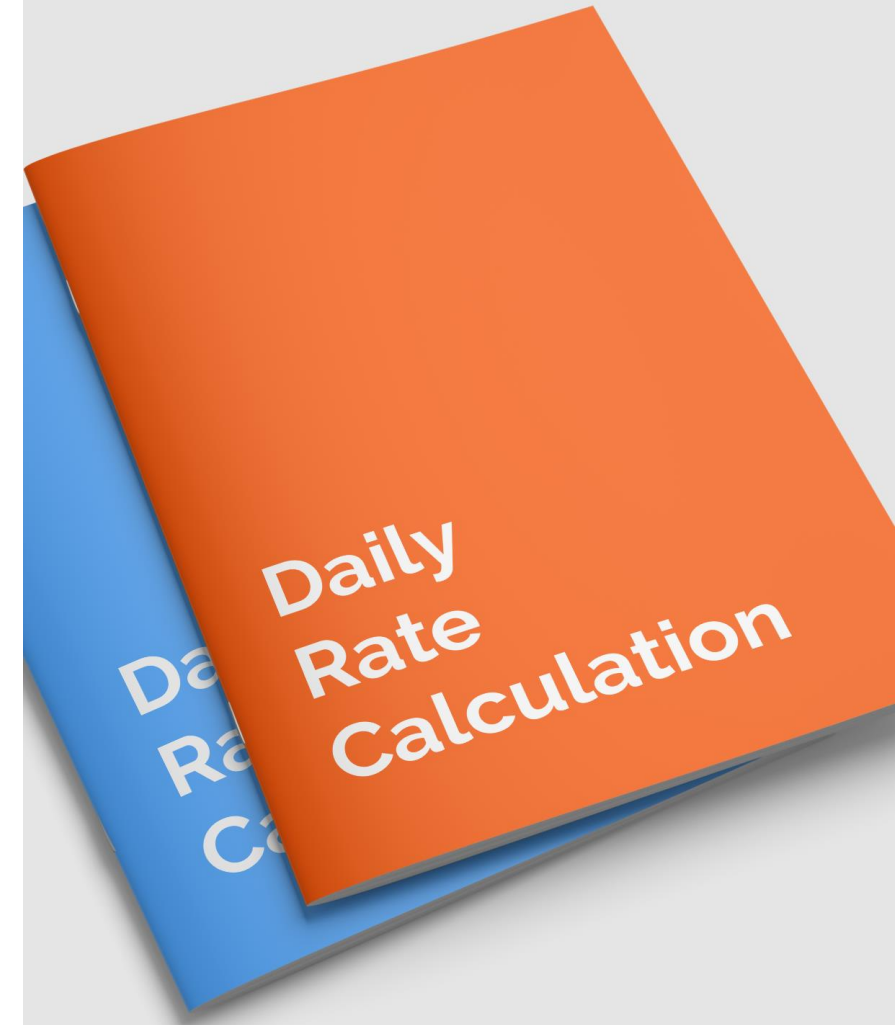
How to calculate the daily rate?

{annual personnel costs for the person divided by 215}

The number of actual days declared for a person must be identifiable and verifiable.

$$\text{Daily Rate} = \frac{\text{annual personnel costs for the person}}{215}$$

Days worked = Monthly declarations instead of time sheets



System and Process Audit

What is a SPA?

A risk assessment & an audit opinion

in **2** steps:

- Test of the systems/ Tests of controls
- Substantive testings/
Tests of transactions

HE Rfp Article 48

assessing **3** types of risks:

- Inherent Risk at the level of the entity
- Control Risk at the entity level
- Budget Category Specific Control Risk
and their project based accounting

providing **1** Output:

- One single report in two parts
- Combined review result > flag as Low, Medium or High

Prepare for Horizon Europe

Internal strategy

- The EU research agenda analysis
e.g. BOHEMIA study and R&I missions - where is your organisation?
- Internal research excellence
Focus areas to support
- Funding strategy
Do you remember the complementarities?
- Who should be involved in this discussion?
- How to increase capacities and generate a better environment for fundraising?
- What lobbying can you do?
- How can you increase your visibility? And access to relevant information?

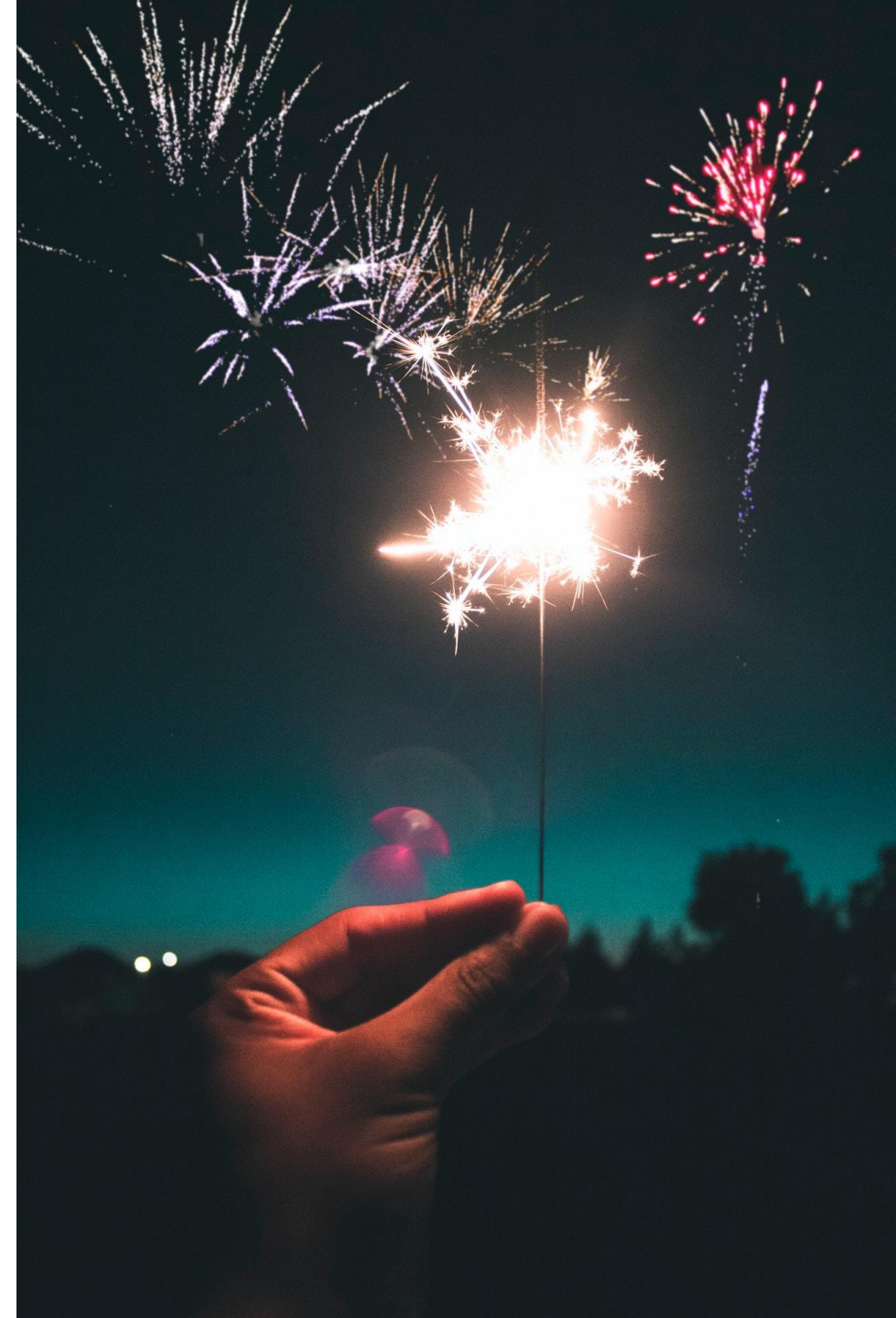
